

**COVENANT AND AGREEMENT AND  
DECLARATION OF RESTRICTIONS**

This **COVENANT AND AGREEMENT AND DECLARATION OF RESTRICTIONS** ("Covenant and Agreement"), dated this 27<sup>th</sup> day of February, 2003 (for reference purposes only), is made and entered into by **SANDA GROUP**, a California limited partnership, its successors, heirs and/or assigns ("Declarant") with reference to the following.

**RECITALS**

- A. Declarant is the fee owner of the following described real property located in the City of Riverside, County of Riverside, State of California ("Property"):
 

Residential Lots 1 through 14, inclusive, and Common Area Lots 15, 16, and B, of Tract No. 28728-2, as shown by Map on file in Book 331, Pages 86 through 90, inclusive, of Maps, records of Riverside County, California.
- B. Declarant has filed with the City of Riverside ("City") an application to develop the Property as a part of a residential planned development subdivision, as defined in Civil Code Section 1351(k), consisting of 14 Residential Lots, 2 open space Common Area Lots, and 1 Common Area Lot for private street purposes.
- C. As a condition of approval of Tract Map No. 28728-2, the City of Riverside ("City") is requiring Declarant to record a document, satisfactory to the Planning and Legal Departments, wherein Declarant covenants and agrees to establish an association of homeowners ("Association") to maintain, manage and operate the Property and to record a Declaration of Covenants, Conditions, Restrictions and Easements ("Declaration") for the Association.
- D. As a further condition of approval, the City requires the Declaration to include the following specific conditions, restrictions and easements:
  1. Prohibit further subdivision of any Lots within the Property;
  2. That the Property is subject to the requirements and the standards for grading set forth in the Alessandro Heights Arroyo and Grading Preservation Study, now codified in Title 17 of the Riverside Municipal Code;

3. Provide natural drainage easements over Lot lines;
4. Restrict the keeping of livestock; and
5. Restrict the use of Common Area Lots 15 and 16 to open space purposes only and maintain as such in perpetuity.

**NOW, THEREFORE**, in accordance with the conditions of approval for Tract Map No. 28728-2 and in consideration of such approval, Declarant hereby covenants and agrees as follows:

1. The further subdivision of the Lots within the Property beyond the subdivision approved by the City is hereby prohibited. The Property shall be limited to fourteen (14) single family Residential Lots, two (2) numbered Common Area Lots and one (1) lettered Common Area Lot.
2. Notice shall be given, in writing, to each prospective purchaser of any Lot of the Property prior to sale of the standards and requirements for grading upon the Lots within Tract No. 28728-2 which standards and requirements are set forth in the Title 17 of the Riverside Municipal Code . The Notice shall be in such form and content as approved by the Planning and Legal Departments of the City.
3. There are hereby established, granted and reserved natural drainage easements over Lot lines within the Property to allow surface runoff water and storm water to flow according to natural drainage patterns on the Property; and the natural drainage pattern on the Lots may be altered with the development of a single family dwelling to the extent required to accommodate such development pursuant to a grading permit issued by the City of Riverside.
4. Each Owner of a Lot of the Property shall maintain the natural drainage facilities upon such Lot in a good, usable and safe condition at all times, shall keep such drainage facilities free from obstruction and shall make any repairs as may be necessary to ensure proper drainage.
5. All Lots in the Property are hereby prohibited from keeping any livestock notwithstanding that such use on Lots exceeding one (1) acre in size would otherwise be permitted under Title 17 of the Riverside Municipal Code.
6. Declarant shall establish an Association to maintain, manage and operate the Property, and to record a Declaration for the Association.
7. Declarant or the Association shall maintain the open space easement over Common Area Lots 15 and 16, as shown on the recorded Map for Tract No. 28728-2. Lots 15 and 16 are intended for open space purposes only and it is hereby covenanted and agreed that they shall be kept free of buildings, structures, materials, equipment, earthfill or deposits and that no grading, construction, fencing or access over said Lots by the public is permitted thereon. The open space easement may be maintained by an agreement with the Riverside Land Conservancy subject to the approval of the Planning and Legal Departments.
8. Declarant, by recordation of this Covenant and Agreement, prior to or concurrently with the recordation of the Map for Tract No. 28728-2, hereby gives notice to all prospective buyers of any Lot of the Property that the Property shall be subject to the foregoing specific covenants, conditions, restrictions and easements set forth in the Declaration.



9. The terms of this Covenant and Agreement may be enforced by the City of Riverside, its successors or assigns, or by any Owner or Tenant of any Lot of the Property. Should the City or any Owner or Tenant bring an action to enforce any of the terms of this Covenant and Agreement, the prevailing party shall be entitled to reasonable attorneys' fees, expert witnesses' fees and reasonable costs of suit.

10. This Covenant and Agreement shall run with the land and shall be binding upon Declarant, its successors and assigns and shall continue in effect until such time as it may be released by the Planning Director of the City of Riverside by a writing duly recorded, provided however, this Covenant and Agreement shall terminate and be of no further force and effect at such time as a Declaration of Covenants, Conditions, Restrictions and Easements for the Association is recorded containing the above provisions, and a Notice to that effect, is executed by the Planning Director of the City and duly recorded.

11. This instrument contains the entire agreement entered into by Declarant relating to the responsibilities herein agreed to and the obligations herein assumed. Any oral representations or modifications concerning this instrument shall be of no force and effect excepting a subsequent modification in writing, signed by Declarant, approved by the Planning Director of the City and recorded in the Office of the County Recorder Riverside County, California.
