



That portion of Block 9, Range 3, Map of the Town of Riverside, in the City of Riverside, County of Riverside, State of California, shown by a map file in Book 7, page 17 of Maps, in the Office of the County Recorder of San Bernardino County, being portions of those Real Properties Relinquished by the State of California Highway Commission recorded July 28, 1958, in Book 2308, page 454, and the other, recorded April 27, 1972, as Instrument No. 54582, of Official Records of said County, described as follows:

COMMENCING at a point on line parallel with and distant southwesterly 8.00 feet measured at right angles from the northeasterly line of said Block 9, Range 3, said point being the southeasterly terminus of that certain course cited as "North 60°13'35" West, 86.14 feet" as described by a Quit Claim Deed to Regional Properties, INC., recorded May 15, 2012 as Instrument No. 2012-0224765, of Official Records of said County; thence along said parallel line North 60°13'35" West, 69.56 feet to the intersection of the southeasterly line of said Real Property described by said Instrument No. 54582, said intersection being the POINT OF BEGINNING; thence along said southeasterly line South 47°42'04" West, 76.37 feet to a line parallel with and distant southeasterly, 20.00 feet measured at right angles from the northwesterly line of said Block 9, Range 3; thence along said parallel line North 29°43'25" East, 59.92 feet; thence North 74°33'51" East, 17.95 feet to a line parallel with and distant southwesterly 8.00 feet measured at right angles from the northeasterly line of said Block 9, Range 3; thence along said parallel line South 60°13'35" East, 10.91 feet to the POINT OF BEGINNING.

The bearings and distances used in the above descriptions are based on the California Coordinate System of 1983, Zone 6. Divide distances shown by 0.9999727 to obtain ground level distances.






