BEGINNING at the most southerly corner of Parcel 3 of said Record of
Survey;
Thence North 29° 30' 04" East, along the Southeasterly line of said
Parcel 3, a distance of 70.00 feet;
Thence South 46° 23' 14" East, 86.63 feet;
Thence South 31° 28' 03" East, 34.09 feet to the Northeasterly
prolongation of the Northwesterly line of Lot 4 of City Park Tract as
shown by map on file in Book 13, Page 52 of Maps, records of said County;
Thence South 29° 00' 00" West, along said Northeasterly prolongation,


