

RESOLUTION NO. 1304 (NEW SERIES)

RESOLUTION OF THE COUNCIL OF THE CITY OF RIVERSIDE,
CALIFORNIA, ACCEPTING A DEED FOR A RIGHT-OF-WAY FOR
ELECTRIC POLES, LINES WIRES, ETC.

RESOLVED; by the Council of the City of Riverside, California,
that deed dated March 6, 1931, executed by JAMES RICHMOND, a single per-
son, to the CITY OF RIVERSIDE, a municipal corporation, of the County of
Riverside, State of California, for a right-of-way for electric poles,
lines and wires, over and across the following described premises situat-
ed in the City of Riverside, County of Riverside, State of California, and
more particularly described as follows, to-wit:

The center line beginning at a point on the southerly line of
Lot 190, 5' westerly from the easterly line of said lot, thence northerly
parallel to the easterly line of said lot, 100'. All being a portion of
S.C.C.A. lands being recorded in Book 7 of Maps, page 3 records of San
Bernardino County, June 8, 1871, together with the right of entry upon
said premises for the purpose of installing, maintaining and repairing
said lines and wires, and to enjoy the use of said right-of-way free
and clear of building, trees or other obstructions,

be, and the same is hereby, accepted; and

BE IT FURTHER RESOLVED; that a copy of this resolution be
attached to said deed and that the same be recorded in the office of the
County Recorder of Riverside County, California, and thereafter filed in
the office of the City Engineer of said City of Riverside.


