DEED TO RIGHT-OF-WAY

This indenture, made this 30th day of October, 1931  
by and between Elizabeth Kinzell, grantor, and the City of  
Riverside, a municipal corporation situated in the County of  
Riverside, State of California, grantee.

Witnesseth:

That said grantor hereby grants, transfers and conveys  
to said grantee, a right-of-way, the center line of which  
is hereinafter described, for the purpose of installing and  
maintaining thereon underground conduits and cables necessary  
to convey electric energy, which conduits and cables shall be  
installed below the surface of the ground in a position to  
afford the least interference to any buildings and/or founda-  
tions that might be constructed along the line of right-of-way.  
The center line of said right-of-way is particularly described  
as follows:

Beginning at a point on the easterly line of Orange Street  
133' southerly from the southerly line of Eighth Street, thence  
easterly parallel to the southerly line of Eighth Street, for  
a distance of 149'.

RESOLUTION OF THE COUNCIL OF THE CITY OF RIVERSIDE  
ACCEPTING A DEED FOR A RIGHT-OF-WAY FOR UNDERGROUND  
CONDUITS AND CABLES.

RESOLVED; by the Council of the City of Riverside, California,  
that deed dated October 30, 1931. executed by ELIZABETH KINCELL to the  
CITY OF RIVERSIDE, a municipal corporation, of the County of Riverside,  
State of California, for a right-of-way for underground conduits and  
cables for the purpose of transmitting electrical energy across a por-  
tion of Range 5, Block 8, Town of Riverside, the center line of said  
right-of-way being described as follows, to-wit:

Street 133' southerly from the southerly line of  
Eighth Street, thence easterly parallel to the south-  
erly line of Eighth Street, for a distance of 149',


