ing described premises situated in the City of Riverside, County of River-  
side, State of California, and more particularly described as follows,



Thence Easterly along the Northerly line of said Lot 15 to a point 20 feet measured at right angles Southeasterly from the Southeasterly line of Gage Canal Right of Way;

Thence Southwesterly on a line 20 feet measured at right angles Southeasterly from and parallel with the Southeasterly line of Gage Canal Right of Way, 746.48 feet;

Thence South  $31^{\circ} 47'$  West to said Southerly line of Lot 15;

Thence Westerly along said Southerly line of Lot 15 to the point of beginning.





Portion of Block "E" Arlington Heights.




