THIS INDENTURE, Made and entered into this 16th day of *November*, 1936, by and between Riverside ^{City} School District, a corporation, party of the first part, and the City of Riverside, a municipal corporation, party of the second part;

WITNESSETH:

That for a valuable consideration the party of the first part does hereby grant, bargain, sell and convey to the party of the second part, all that certain real property situate in the City of Riverside, County of Riverside, State of California, and described as follows:

A right-of-way for the construction and maintenance of a concrete storm drain over and across a portion of Lot 54 of S.C.C.A. Lands as shown on a map recorded in Map Book 7 at page 3 Records of San Bernardino County, California:

A strip of land 6 feet in width being 3 feet on each side of the following described center line, the sidelines of said right-of-way being parallel to, and 3 feet distant, measured at right angles, from said center line and extending to intersection with street lines;

Beginning at a point in the center line of Orange Street which bears North 29° 01' East and 331 feet distant from a cement point marking the Southeast corner of said Lot 54; thence North 59° 48' West, a distance of 386.50 feet; thence North 7° 27' West a distance of 285.90 feet; thence North 34° 30' West a distance of 229.42 feet to a point in the center line of Main Street; which bears North 4° 10' East and distant 189.44 feet from the intersecting center lines of Main Street and Stoddard Avenue; excepting therefrom portions of the above description lying within Orange Street and Main Street, as shown by map attached hereto and made a part hereof;

together with the right of ingress and egress for maintaining, repairing and replacing said storm drain.

2 RESOLUTION OF THE COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, ACCEPTING A DEED.

5 RESOLVED; by the Council of the City of Riverside, California,
6 that deed dated November 16, 1936, executed by RIVERSIDE CITY SCHOOL
7 DISTRICT, a corporation, to the CITY OF RIVERSIDE, a municipal corpora-
8 tion, of the County of Riverside, State of California, for the following
9 described premises situated in the City of Riverside, County of River-
10 side, State of California, and more particularly described as follows,
11 to-wit:

12 A right-of-way for the construction and maintenance
13 of a concrete storm drain over and across a portion
14 of Lot 54 of S. C. C. A. Lands as shown on a map
recorded in Map Book 7 at page 3 Records of San Bern-
ardino County, California:

15 A strip of land 6 feet in width being 3 feet on each
16 side of the following described center line, the side-
17 lines of said right-of-way being parallel to, and 3 feet
distant, measured at right angles, from said center line
and extending to intersection with street lines;

18 Beginning at a point in the center line of Orange Street
19 which bears North $29^{\circ} 01'$ East and 331 feet distant from
20 a cement point marking the Southeast corner of said Lot
21 54; thence North $59^{\circ} 48'$ West, a distance of 386.50 feet;
22 thence North $7^{\circ} 27'$ West a distance of 285.90 feet; thence
23 North $34^{\circ} 30'$ West a distance of 229.42 feet to a point in
24 the center line of Main Street; which bears North $4^{\circ} 10'$
East and distant 189.44 feet from the intersecting center
lines of Main Street and Stoddard Avenue; excepting there-
from portions of the above description lying within Orange
Street and Main Street, as shown by map attached hereto
and made a part hereof;

25 be, and the same is hereby, accepted; and

26 BE IT FURTHER RESOLVED; that a copy of this resolution be attached
27 to said deed and that the same be recorded in the office of the County Re-
28 corder of Riverside County, California, and thereafter filed in the office
29 of the City Clerk of said City of Riverside.





THIS AGREEMENT made and entered into this 3 day
of ~~March~~ ^{April}, 1950, by and between the CITY OF RIVERSIDE, a municipal
corporation, hereinafter referred to as the City, and RIVERSIDE
CITY SCHOOL DISTRICT, a school district of the State of Cali-
fornia located in the County of Riverside, hereinafter referred
to as the District,

WHEREAS, on the 16th day of November, 1936, the Dis-
trict executed a Deed in favor of the City conveying a certain
right of way for the construction and maintenance of a concrete
storm drain, and reference is hereby made to said Deed which was
recorded on the 7th day of December, 1936, in Book 304 of Official
Records at page 331, Records of Riverside County, California; and,

WHEREAS, the District is presently contemplating the
construction of a new school building and desires that said build-
ing in part be constructed and maintained upon a portion of the
above referred to right of way; and,

WHEREAS, the proper maintenance, replacement, repair
and inspection of said storm drain will not be interfered with
if certain conditions are met by the District in reference to
the maintenance of said building on said storm drain.

W I T N E S S E T H :

That for valuable consideration the City does hereby
grant a license to the District to erect and maintain a school
building over and upon a portion of the above referred to right
of way hereinafter described, and conditional upon the terms
hereinafter set forth.

That the portion of said right of way upon which the
District is allowed to erect, construct and maintain a school
building is that portion of the hereinafter described right of
way which is underscored; that the right of way with the underscored

1 description upon which the license is granted is located in
2 the County of Riverside, State of California, and reads as
3 follows:

4 A strip of land 6 feet in width, being 3 feet on
5 each side of the following described center line, the
6 side lines of said right of way being parallel to and
7 3 feet distant, measured at right angles from said
8 center line, and extending to intersection with street
9 lines.

10 Beginning at a point in the center line of Orange
11 Street which bears North 29° 01' East and 331 feet
12 distant from a cement point marking, the Southeast
13 corner of said Lot 54; thence North 59° 48' West a dis-
14 tance of 386.50 feet; thence North 7° 27' West a distance
15 of 285.90 feet; thence North 34° 30' West a distance of
16 15 feet, more or less, to a point five feet from the
17 Southerly side of a proposed building, the true point
18 of beginning; thence continuing North 34° 30' West a
19 distance of 135 feet, more or less, to a point 10 feet
20 Northwesterly from the westerly side of said proposed
21 building.

22 That this license is granted by the City to the Dis-
23 trict upon the following terms and conditions:

24 1. That all building foundations will be trussed over
25 the storm drain and for at least two (2) feet on each side
26 thereof.

27 2. The District will construct, at its own expense, a
28 manhole over the storm drain in the open area between the wings
29 of the building, as indicated on plans on file in the office of
30 the City Engineer.

31 3. The District agrees that in the event it becomes necessary
32 for the City to repair, replace, maintain or inspect the storm drain
located under the building that the District will, at its own
expense, remove any portion or all of the building located on the
licensed area.

33 4. The City Engineer shall have the sole power to determine
34 the amount of building to be removed, if and when, in his judgment,
35 the same becomes necessary.

36 5. All plans for trussing the foundation over the storm
37 drain and construction of the manhole shall be prepared by the

1 District and must be approved by the City Engineer. One copy
2 of the approved plans shall be filed with the City Clerk and
3 one copy with the City Engineer.

4 7. Upon the failure of the District to remove any portion
5 of the school structure from the right of way when required to
6 do so by the City Engineer in order to repair, replace, maintain
7 or inspect the storm drain, the City shall have the right to go
8 upon the property and remove any and all structures or buildings
9 upon said licensed portion of the said right of way, and the
10 cost of the removal of any building or structure, or part thereof,
11 shall be borne by the District.
