

DEED OF RIGHT-OF-WAY

THIS INDENTURE, made this 15th day of December, 1939, by and between CLINE C. WHITE and EVA M. WHITE, husband and wife, of Riverside, California, party of the first part, and the CITY OF RIVERSIDE, a municipal corporation, in the County of Riverside, State of California, party of the second part;

WITNESSETH: That in consideration of the sum of One Dollar lawful money of the United States to the said party of the first part in hand paid by the said party of the second part, receipt whereof is hereby acknowledged, said party of the first part does by these presents grant unto the said party of the second part, its successors and assigns forever, an easement and right-of-way for the laying and maintenance of water lines, pipes and appurtenances over, across and through that certain real property situate in the City of Riverside, County of Riverside, State of California, described as follows:-

Lot A of the Cline C. White Subdivision, as shown by map recorded in Book 19 page 64 of Maps, records of Riverside County, California;

TOGETHER with the right of entry upon the premises over and across which said easement and right-of-way is hereby granted for the purpose of installing, maintaining, repairing and renewing said pipe lines, pipes and appurtenances.


