

GRANT DEED

In consideration of One and no/100--Dollars, Ruth Kerr, a widow, John Kerr, also known as John A. A. Kerr, a single man, Alexander H. Kerr, Jr., a married man, W. A. MacRae Kerr, a married man, Wm. S. Kerr, also known as William Samuel Abraham Kerr, a married man, Albertina Ruth Kerr, a single woman and Constance Elizabeth Kerr, a single woman,

do hereby grant to the CITY OF RIVERSIDE, all that real property situate in the City of Riverside, County of Riverside, State of California, described as follows:

A strip of land one-hundred feet in width, being fifty feet on each side of a certain center line, said center line being described as follows:

Beginning at a point on the center line of Central Avenue 188.66 feet westerly from the center line intersection of Fairview Avenue as shown on Map of Victoria Ranch as recorded in Book 4 of Maps at page 59 thereof, Records of Riverside County California; said point being the beginning of a curve concave to the southwest and having a radius of 600.00', thence southeasterly along said curve through an arc of 37°07'30" a distance of 388.69'; thence S 54°02' E a distance of 84.19' to the beginning of a curve concave to the southwest and having a radius of 600.00'; thence southerly along said curve through an arc of 41°08'30" a distance of 430.83'; thence S 12°53'30" E a distance of 881.43' to the beginning of a curve concave to the northeast and having a radius of 600.00'; thence southeasterly along said curve through an arc of 69°28'30" a distance of 727.54'; thence S 82°22' E a distance of 42.83' to the beginning of a curve concave to the southwest and having a radius of 600.00'; thence southeasterly along said curve through an arc of 63°22'30" a distance of 663.54'; thence S 18°59'30" E a distance of 382.25' to the northerly line of Tequesquite Heights Subdivision as recorded in Book 10 of Maps at page 31 thereof, Records of Riverside County, California, said point of intersection being S 89°15' W a distance of 26' from the monument line of Elsinore Road as shown on said subdivision.

The grantors understand that the present intention of the grantee of the lands hereby conveyed in fee is to construct and maintain thereon a City Street. The Grantors hereby waive any claim for any and all damages to any other real property owned by the grantors, contiguous to the lands hereby conveyed, by reason of the location, construction or maintenance of said highway.

It is understood that the grantors herein own a portion only of the above described strip of land and by their signatures convey only that portion owned by each of them.

EXCEPTING herefrom and reserving to the grantors herein mentioned, their successors and assigns, an easement and right-of-way to install, construct, maintain, repair, replace, use and operate such water pipe line or water pipe lines across the lands herein conveyed, as may be reasonably necessary or convenient for the




