An easement and right of way for drainage purposes, 10 feet in width, over that portion of the Southwest Quarter of the Northeast Quarter of Section 34, Township 2 South, Range 5 West, San Bernardino Base and Meridian, particularly described as follows:

Commencing at the Southeast corner of the Southwest Quarter of Northeast Quarter; Thence South 89° 16' West, 500 feet; Thence North 0° 03' 30" West, 25 feet to the North line of Central Avenue and the true point of beginning; Thence continuing North 0° 03' 30" West, 384 feet; Thence South 89° 16' West, 10 feet; Thence South 0° 03' 30" East, 384 feet to the North line of Central Avenue; Thence North 89° 16' East, 10 feet to point of beginning.


