THIS INSTRUMENT, made this 17 day of February in the year of our Lord, Nineteen Hundred and Forty-Eight, between JENNIE ANDERSON, party of the first part, and the CITY OF RIVERSIDE, a municipal corporation of the State of California, the party of the second part:
WITNESSETH: That said party of the first part, for and in consideration of the sum of One Dollar (\$1.00), lawful money of the United States of America, to them in hand paid by the party of the second part, the receipt whereof is hereby acknowledged, do by these presents grant unto the said party of the second part, a perpetual easement and right of way for public street purposes over and along that certain parcel of land in the City of Riverside, County of Riverside, State of California, described as follows:

The NWly 10 ft. of the SEly 35 ft. of lot 54 "Lands of Southern California Colony Association" as per map recorded in Book 7, page 3, of Maps in the office of the County Recorder of San Bernardino County, California.

Said NWly 10 ft. being further described as that 10 ft. strip of land lying NWly of and adjoining that certain 25 ft. strip of land deeded to the City of Riverside for highway purposes, by deed recorded in Book 147, pages 98 and 100 of Deeds, in the office of the County Recorder of Riverside County, California.

It is understood that each owner grants only that portion of the above described 10 ft. strip included within his fee.

It is agreed by the party of the second part that they will move, at their expense, any fences now located on said easement.


