Witnesseth: That the said part One of the first part, for and in consideration of the sum of One Dollar,

lawful Money of the United States of America, to him in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, Hath remised released and quit-claimed and by these presents DOth remise release and quit-claim unto the said party of the second part, and to its <sup>Successors</sup> heirs and assigns forever, all that certain lot, piece or parcel of land situate, lying and being in the Said County of San Bernardino, State of California and bounded and particularly described as follows, to wit:—

A strip of land seventeen feet in width and running along and across the westerly line of the West half of lot number six of the lands of the Southern California Colony Association as surveyed by Goldsworthy and Dyble in 1870 a map of which survey is now of record in the office of the Recorder of Deeds of San Bernardino County State of California to be used by the party of the second part for the public use and benefit as a highway—subject however that to the following condition viz: that said land shall be at all times used for such purpose and that the present established grade of the street adjoining said land to be maintained by the party of the second part.
