19 westerly line of Lots 15, 17, and 19 a distance of one
20 hundred thirty feet ($130'$) to the most westerly corner
21 of said Lot 19; thence North $60^{\circ} 55'$ West a distance
22 of fifteen feet ($15'$) to a point in the southeasterly
23 line of Lot 16; thence North $29^{\circ} 05'$ East along the
24 southeasterly line of Lots 16 and 14 a distance of
25 one hundred seven feet ($107'$) to a point; thence North
26 $15^{\circ} 55'$ West a distance of eleven and thirty-one
27 hundredths feet ($11.31'$) to a point in the north-
28 easterly line of said Lot 14; thence North $60^{\circ} 55'$
29 West along the northeasterly line of said Lot 14 a
30 distance of one hundred thirty and ninety-three
