

RESOLUTION NO. 5663

RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF ORDINANCE OF INTENTION NO. 1852 : AND ORDER OF VACATION IN THE MATTER OF AN UNNAMED ALLEY AS SHOWN ON MAP OF RIVERSIDE FRUIT COMPANY'S SUBDIVISION.

WHEREAS, the Mayor and City Council of the City of Riverside, California, adopted an ordinance of intention No. 1852, pursuant to the provisions of the Street Vacation Act of 1941, being Part 3, Division 9 of the Streets and Highways Code of the State of California, declaring its intention to vacate a ~~public alley~~ unnamed public alley ~~located in the Riverside Fruit Company's Subdivision~~, therein and hereinafter described; and,

WHEREAS, the matter came on regularly for hearing before said Mayor and Council at the time and place fixed for hearing by said ordinance of intention, and said Mayor and Council heard and considered all of the evidence submitted.

NOW, THEREFORE, BE IT RESOLVED by said Mayor and Council that it be and is hereby found and determined by said Mayor and City Council that said ordinance of intention was duly passed, adopted, and posted in the manner prescribed by law for the adopting and posting of ordinances of said City, and the notice of said vacation proceedings and of the time and place of hearing was given by posting, as provided by the Street Vacation Act of 1941, and that the said ~~public alley~~ public alley therein described is unnecessary for present or prospective public purposes and should be vacated.

NOW, THEREFORE, pursuant to the provisions of the said Street Vacation Act of 1941 it is hereby ordered by the Mayor and City Council of the City of Riverside, California, that ~~the unnamed public alley~~ the unnamed public alley ~~located in the Riverside Fruit Company's Subdivision~~ commonly known as in the City of Riverside, County of Riverside, State of California, described as follows, to wit:

That certain alley as shown on a map of the Riverside Fruit Company's Subdivision, recorded in Book 5, page 24, of Maps, Records of San Bernardino County, being in Block 9, Range 1, and extending from Vine Street on the west to Santa Fe Avenue on the east, and lying between Ninth Street and Tenth Street,
