RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING THE OFFER OF DEDICATION OF A PORTION OF JUNELLE AVENUE AS A PUBLIC STREET.

WHEREAS, the Mayor and Council of the City of Riverside, California, have heretofore approved the Subdivision Map of Magnolia Center Tract, as recorded in Book 17 of Maps, page 46, Records of Riverside County, California; and,

WHEREAS, the resolution approving said map does not accept the offer of dedication of Junelle Avenue, as shown on said map, as a public street; and,

WHEREAS, the portion of Junelle Avenue which is hereinafter described is being used and improved as a public street, in accordance with the minimum requirements of the ordinance of the City of Riverside, and the public convenience and welfare will be served by a formal acceptance of the offer of dedication of said street.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, that the offer of dedication of the portion of Junelle Avenue which is bounded on the north by Lots 16 and 17, and on the South by Lots 79 and 80, as shown on the map of Magnolia Center Tract recorded in Book 17 of Maps, page 46, Records of Riverside County, as a public street, be and the same is hereby accepted; and that the portion of Junelle Avenue herein described be accepted as a public street.
