15 The Northerly Ten Feet (10') of the Southwest Quarter
 16 (SW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of the Northeast
 17 Quarter (NE $\frac{1}{4}$) of Fractional Section 24, Township 2 South,
 18 Range 5 West, S.E.E.34.

19 EXCEPTING therefrom the Westerly Two Hundred Feet (200')
 20 thereof.

21 TOGETHER WITH the right of entry upon said premises over and
 22 across which said easement and right-of-way is granted, for the pur-
 23 pose of installing, maintaining and repairing said ducts, cables,
 24 wires and equipment and to enjoy the use of said easement and right-
 25 of-way free and clear of buildings, trees and other obstructions.

26 Nothing herein contained shall be construed as a grant to
 27 the City of Riverside of any right to install or maintain overground
 28 or surface installations.
