A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF THE PUBLIC UTILITY EASEMENT ON LOT 28 OF DONALD AVENUE EXTENSION.

WHEREAS, on the 8th day of March, 1955, Ordinance No. 2184 of the City of Riverside, California, was adopted, declaring the intention of the City Council to vacate a portion of the public utility easement on Lot 28 of Donald Avenue Extension, pursuant to the provisions of the Public Service Easements Vacation Law; and.

WHEREAS, in said ordinance the time of hearing was set for Tuesday, May 3, 1955, at 10 o'clock A. M. in the Council Chambers located in the City Hall, Seventh and Orange Streets, Riverside, California, at which said time and place all persons interested in or objecting to the proposed vacation be allowed to be heard; and,

WHEREAS, notice of hearing was given as provided by Section 50441 of the Government Code of the State of California; and,

WHEREAS, a hearing of the ordinance of intention was had before said legislative body at the time and place fixed, at which time the evidence offered by persons interested was heard by the legislative body and the legislative body found from all of the evidence submitted that the portion of the public utility easement which the legislative body declared its intention to vacate is unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that the portion of the public utility easement on Lot 28 of Donald Avenue Extension in the City of Riverside, County of Riverside, State of California, and described as follows:

That portion of a Public Utility Easement on Lot 28 of Donald Avenue Extension shown on a map recorded in Map Book 25, at page 99,

1 Records of Riverside County, described as  
follows:

2 The southeasterly forty-four and two  
tenths feet (44.2') of the northeasterly ten  
3 feet (10') of said Lot 28;

4 is unnecessary for present or prospective public use, and that  
5 the same be and is hereby vacated.

6 IT IS FURTHER ORDERED that the Clerk cause a certified copy  
7 of this order, attested by him under seal, to be recorded in the  
8 Office of the County Recorder of Riverside County, California.
