1 For a valuable consideration, receipt of which is hereby acknowledged,  
2 W.E. Walter S. Roeder and Eva M. Roeder, his wife, Harold W. Heers  
3 and Virginia R. Heers, his wife, and Carol D. Heers and Evelyn M.  
4 Heers, his wife, do hereby Grant to The City of Riverside, California,  
a municipal corporation, for public street purposes, the real property  
in the City of Riverside, County of Riverside, State of California,  
described as:

5 All that portion of the South half of the North Half of  
6 Section 34, Township 2 South, Range 5 West, San Bernardino Base and  
Meridian as shown on United States Government Survey and more partic-  
ularly described as follows:

7 Beginning at a point on the Southeasterly line of Magnolia  
8 Avenue, 20 feet South of and measured at right angles to the West-  
9 erly extension of the Southerly line of Parcel 1 as shown on Record  
of Survey on file in Book 9 page 2 of Records of Survey, records of  
Riverside County, California;

10 Thence Easterly and parallel with the Southerly lines and  
the Westerly extension thereof of Parcels 1, 4 and 5 of said Record
