Do **SS** Hereby Grant to **CITY OF RIVERSIDE, a municipal corporation**
for public street purposes,

the real property in the **City of Riverside**

County of **Riverside**, State of California, described as follows:

A portion of Lot 6, Block 14, Riverside Land and Irrigating Co, as shown on a map recorded in Map Book 1, at page 70, Records of San Bernardino County, described as follows:

Beginning at the Southeasterly corner of said Lot 6, thence Westerly along the Southerly line of said Lot 6, a distance of thirty-two and twenty-five hundredths feet (32.25'), thence Northerly along a curve concave to the East having a radius of two hundred nine and sixty-seven hundredths feet (209.67'), through a central angle of 32° 12' 03", an arc length of one hundred seventeen and eighty-four hundredths feet (117.84') to a point in the Easterly line of said Lot 6, thence Southerly along the Easterly line of said Lot 6, a distance of one hundred eleven and seventy-three hundredths feet (111.73') to the Southeasterly corner of said Lot 6, the point of beginning.


