A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A RIGHT OF WAY EASEMENT FOR PUBLIC UTILITY PURPOSES IN, OVER AND ACROSS LOT 13 IN BLOCK 4 OF LANDS OF THE RIVERSIDE LAND AND IRRIGATING COMPANY.

WHEREAS, it appears that the City of Riverside has an easement and right of way for public utility purposes in, over and across Lot 13, in Block 4 of Lands of the Riverside Land and Irrigating Company, along the course hereinafter described; and,

WHEREAS it appears that said easement and right of way is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easement and right of way for public utility purposes be and the same is hereby vacated. The said easement is situate in the City of Riverside, County of Riverside, State of California, and is described as follows:

That certain real property ten (10) feet wide, the centerline of which is 215 feet southeast-erly from the northwesterly corner of Lot 13, in Block 4 of Lands of the Riverside Land and Irrigating Company, as shown by map recorded in Book 1, page 70 of Maps, Records of San Bernardino County, California, extended northeasterly at right angles to the westerly line of said Lot 13, 380 feet.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.
