WE, the undersigned, all of the City of Riverside, County of Riverside, State of California, DO HEREBY GRANT unto the CITY OF RIVERSIDE, a Municipal Corporation, organized and existing under and by virtue of the laws of the State of California, a certain strip of land in said city described as follows, to-wit:-

A strip of land extending one foot on each side of a line beginning at a point in the westerly line of and distant 81 feet northerly of the southwesterly corner of Block 8, Range 10, as recorded in Book 7 at page 17, records of San Bernardino County, State of California, for an initial point; thence easterly and parallel with the southerly line of said Block 8, Range 10, a distance of 147 feet. Said line to define the middle line of a strip of land two feet in width to be used for sewer purposes only.
