WITNESSETH:- That for and in consideration of the sum of Ten Dollars (\$10.00) in hand paid by the said second party, the receipt whereof is hereby acknowledged, said first parties do hereby grant unto the said second party a right of way for a public sewer, in the City of Riverside, County of Riverside, State of California, which said right of way is bounded and particularly described as follows, to-wit:-

A strip of land two feet in width lying one foot on each side of a line located as follows:- Beginning at a point in the Easterly line of Block 8, Range 11, of the Town (now City) of Riverside, as surveyed by Goldsworthy and Higbie and of record in Book #7 of Maps, page 17, Records San Bernardino County, California, said point being 96 feet Southerly the Northeasterly corner of said Block 8, Range 11; thence Westerly and parallel with the Northerly line of said Block 8, Range 11, a distance 188 feet.
