

This Indenture, Made this 29th day of December, in the year
of our Lord One thousand nine hundred nine, 515

Witnesseth: That, whereas the certain promissory note for the sum of Five hundred fifty Dollars with interest, mentioned as secured by that certain Deed of Trust made by D. S. Stokes and Jannie M. Stokes, his wife, to the Merchants Trust Company, a corporation, as the second party, which said Deed of Trust is dated the 12th day of September, 1905, and recorded in the records of Riverside County, California, in Book 213 page 32 of Deeds, has been partially paid, and it is desired to discharge said trust as to the premises hereinafter described:-

Now, Therefore, In consideration of such partial payment and the receipt of one dollar, and at the request of the Riverside Savings Bank and Trust Company, party of the third part mentioned in said Deed of Trust, the Merchants Trust Company does hereby remise, release and reconvey unto D. S. Stokes, his heirs and assigns, all the estate in the premises described as a strip of land one hundred feet in width through Section Thirty four (34), Township Two (2) South, Range Five (5) West, San Bernardino Meridian, lying fifty feet on each side of a line drawn from a cement point set in the center line of Cypress Avenue, and thirty three feet distant from (measured at a right angle to the North of) the North line of Section Thirty four (34) Township Two (2) South, Range Five (5) West, as surveyed for the Southern California Colony Association; thence in a South West direction to a cement point set at the intersection of the center line of Arlington Avenue (the same being the South line of said Section 34) with the center line of Magnolia Avenue in the City of Riverside, said line passing through a certain tract of land lying North of Block Two (2), Tibbett's Tract, in Section Thirty four (34), Township Two (2) South, Range Five (5) West, as shown by map of the said Tibbett's Tract recorded in the

office of the County Recorder of Riverside County, California, and lying South of the Palm Addition, being a Subdivision of a portion of the South West quarter of said Section Thirty four (34), as recorded in Book 6 page 50 of Maps, records of Riverside County, California, in said Deed of Trust acquired by the Trustee therein; reference being hereby made to the record of said Deed for a particular description of said premises, the intention of this corporation acting as Trustee being to acknowledge partial satisfaction of the indebtedness recited in the Deed of Trust, and to reconvey without warranty to D. S. Stokes the estate in said real property acquired by the Deed of Trust,
