BLANKET DEED

THIS INDENTURE, made and entered into by and between the undersigned property owners, owning property in Block 7, Range 8, in the City of Riverside, parties of the first part, grantors, and THE CITY OF RIVERSIDE, a municipal corporation, organized and existing under the laws of the State of California, parties of the second part, grantee,

WITNESSETH, That for and in consideration of the sum of one dollar in hand paid by said party of the second part to the said parties of the first part, the receipt whereof is hereby acknowledged, by each and every one of the parties of the first part hereto, and for other valuable considerations, the said parties of the first part do by these presents grant, bargain, sell, quitclaim, convey and confirm unto the said party of the second part, and to its successors and assigns, forever, all of the right, title and interest of the undersigned property owners parties of the first part in and to all of that certain lot or parcel of land situate in the City of Riverside, County of Riverside, State of California, and more particularly described as follows, to wit:

Beginning at a point in the northerly boundary line of Block 7, Range 8, of the Town, now City of Riverside California, as recorded in the County Recorder's office of San Bernardino County California, in Book 7 of Maps, Page 17, said point being the intersection of the northerly and southerly center line Block 7, Range 8, with the northerly boundary line Block 7, Range 8; thence easterly along said northerly boundary line $7\frac{1}{2}$ feet; thence southerly parallel with the westerly boundary line Block 7, Range 8, to a point $7\frac{1}{2}$ feet southerly from the easterly and westerly center line Block 7, Range 8; thence westerly parallel with the northerly boundary line to a point on the westerly boundary line Block 7, Range 8; thence northerly along the westerly boundary line, of aid lock, $7\frac{1}{2}$ feet, said point being the intersection of the westerly boundary line Block 7, Range 8, with the easterly and westerly center line Block 7, Range 8, thence easterly along said easterly and westerly center line to the center of Block 7, Range 8, thence northerly along the northerly and southerly center line Block 7, Range 8, to the northerly boundary line Block 7, Range 8, the point of beginning.

Together with all and singular, the tenements, hereditaments and appurtenants thereunto belonging, or in any wise appurtenant and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD all and singular, the said promises, together with the appurtenances unto the said party of the second part and to its successors and assigns forever.
