Be it Resolved, this 16th day of May, 1922, by the Common Council of the City of Riverside, County of Riverside, State of California, that those certain deeds to the City of Riverside, aforesaid County and State, as follows:

(1) Deed dated April 20, 1922, executed by Oran C. Snyder, et al., for a sewer right of way in lots 25 and 26, Suman Tract, lot 27, Dr. Bogue Tract and lot 201, S. C. C. A.

(2) Deed dated May 1, 1922, executed by E. O. Stansell, et al., for a sewer right of way in lots 199 and 208, S. C. C. A.; be, and the same are hereby accepted, for the purposes and intentions as therein set forth; and

GRANT OF RIGHT-OF-WAY.

WE E. O. Stansell, ^{his wife} Arnes Stansell, Donald T. Mackay, ^{his wife} Annie H. Mackay, ^{his wife} LeRoy J. Bliss, ^{his wife} Mellie Bliss, Riverside Title Company, a Corporation as trustee, Riverside County Mutual Building & Loan Association, a Corporation.

and each of us, grant to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, an EASEMENT OF RIGHT-OF-WAY for the construction and maintenance of a public sewer over and through the following described premises, situate in the City of Riverside, County of Riverside, State of California, and described as follows, to-wit:

A strip of land four feet in width, lying two feet on each side of a line described as follows; beginning at the most northwesterly corner of Lot 199 of the Lands of the Southern California Colony Association, a map of which is recorded in Book 7 of Maps, Page 3, Records of San Bernardino County, California; thence easterly along the northerly line of said Lot 199, a distance of 33 feet to a point of beginning; thence southerly parallel with and 33 feet from the easterly line of said Lot 199, a distance of 188.8 feet.

Also beginning at the most northwesterly corner of Lot 199 of the Lands of the Southern California Colony Association, a map of which is recorded in Book 7 of Maps, Page 3, Records of San Bernardino County, California; thence southerly, along the westerly line of said Lot 199 a distance of 188.8 feet to a point of beginning; thence easterly parallel with and 188.8 feet from the northerly line of said Lot 199 a distance of 210.5 feet; thence southerly parallel with and 210.5 feet from the westerly line of Lots 199 and 208 of the said Lands of the Southern California Colony Association to a point on the northerly line of Bandini Avenue.

Also beginning at a point on the easterly line of Lot 208 of the Lands of the Southern California Colony Association, a map of which is recorded in Book 7 of Maps, Page 3, Records of San Bernardino County, California, and 188.86 feet northerly from the southerly line of said Lot 208, said southerly line being the center line of Bandini Avenue; thence westerly, parallel with the southerly line of said Lot 208, a distance of 449.5 feet, more or less to a point 210.5 feet easterly from the westerly line of said Lot 208.

Also beginning at a point on the easterly line of Lot 208 of the Lands of the Southern California Colony Association, a map of which is recorded in Book 7 of Maps, Page 3, Records of San Bernardino County, California, and 94.43 feet southerly from the most northeasterly corner of said Lot 208; thence westerly, parallel with and 94.43 feet from the northerly line of said Lot 208, a distance of 449.5 feet, more or less to a point 210.5^{feet} easterly from the westerly line of said Lot 208.

Also beginning at the most northwesterly corner of Lot F. of the Beechwood Place Addition, a map of which is recorded in Book 8 of Maps, Page 86, Records of Riverside County, California; thence southerly, along the westerly line of said Lot F. and the westerly line of said Lot F. produced southerly, a distance of 377.72 feet to a point of beginning; thence westerly, parallel with and 377.72 feet from the northerly lines of Lots 199 and 198 of the Lands of the Southern California Colony Association, a map of which is recorded in Book 7 of Maps, Page 3, Records of San Bernardino County, California, a distance of 456.5 feet, more or less to a point 210.5 feet easterly from the westerly line of said Lot 199.
