

RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF RIVERSIDE ACCEPT-

RESOLVED, by the Mayor and Common Council of the City of Riverside, County of Riverside, State of California, that those certain deeds to the City of Riverside, aforesaid County and State, and briefly described as follows, to-wit:

(1) Deed dated November 13th, 1922, executed by Winnie I. Knoll, for a sewer right of way in Lot 248 of the Lands of the Southern California Colony Association.

(2) Deed dated November 20th, 1922, executed by E. O. Stansell and Agns Stansell, for a portion of Lot 199 of the Lands of the Southern California Colony Association, for the purpose of a public street,

and each of us, grant to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, for the purpose of a public street, the following described premises, situate in the City of Riverside, County of Riverside, State of California, to-wit:

Beginning at a point on the westerly line of Lot 199 of the Lands of the Southern California Colony Association as shown on map recorded in Book 7 of Maps, Page 3, Records of San Bernardino County, California, ~~and~~ 8.25 feet northerly from the southerly line of the northerly one-half of said Lot 199; thence southerly along the westerly line of said Lot 199 a distance of 131.26 feet; thence, easterly, parallel with and 123.01 feet southerly from the said southerly line of the northerly one-half of said Lot 199 a distance of 33 feet; thence northerly, parallel with and 33 feet easterly from the westerly line of said Lot 199 a distance of 131.26 feet; thence westerly, parallel with and 8.25 feet northerly from the said southerly line of the northerly one-half of said Lot 199; a distance of 33 feet to the point of beginning.


