

RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF RIVERSIDE
ACCEPTING A DEED FOR A RIGHT-OF-WAY FOR ELECTRIC POLES, LINES,
WIRES ETC.

RESOLVED; by the Common Council of the City of Riverside, that deed dated March 9, 1927, executed by STEWART REALTY COMPANY to the City of Riverside, a municipal corporation, of the County of Riverside, State of California, for right-of-way for electric poles, lines, wires etc. across the following described premises situated in the City of Riverside, County of Riverside, State of California, and more particularly described as follows, to-wit:

Beginning at a point on northerly side of Potomac Street 150' westerly from Washington Street, thence northerly 180' along easterly property line of lots 7 & 6, and beginning at the north easterly corner of lot 7, going westerly along northerly boundry of lots 7 to 13 inclusive and along southerly boundries of lots 1 to 6 inclusive,
