A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, DEDICATING AND ACCEPTING CERTAIN CITY-OWNED LAND FOR PUBLIC STREET PURPOSES.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the hereinafter described strip or parcel of land owned by the City of Riverside, being a portion of the Piedmont Reservoir property, be and is hereby dedicated by the City of Riverside and accepted for public use for street purposes to become and be known as a portion of Trafalgar Avenue. Said parcel or strip of land is located in the City of Riverside, County of Riverside, State of California, and is described as follows:

All that portion of the northwest quarter of Section 1, Township 3 South, Range 5 West, San Bernardino Base and Meridian, more particularly described as follows:

Beginning at the most southerly corner of Lot 13 of Tract No. 5657, as shown by map on file in Book 91 of Maps, at Pages 64 through 67, inclusive thereof, Records of Riverside County, California;

Thence South 20° 53' 51" East along the boundary line of Lot "C" (Trafalgar Avenue), as shown on said map, a distance of 33.00 feet to an angle point therein, said point being in the centerline of said Trafalgar Avenue, said point also being the southeast corner of that certain parcel of land conveyed to the City of Riverside by deed recorded January 31, 1968 as Instrument No. 9398, Official Records of Riverside County, California;

Thence South 69° 06' 09" West along said centerline and along said parcel so conveyed, a distance of 205.00 feet to the southwest corner thereof;

Thence North 20° 53' 51" West along the boundary line of said parcel, a distance of 33.00 feet to an angle point therein, said point being in a line parallel with and distant northerly 33.00 feet, measured at right angle, from the southeasterly line of said parcel;

Thence North 69° 06' 09" East along said parallel line, a distance of 205.00 feet to the point of beginning.

BE IT FURTHER RESOLVED that the City Clerk is authorized and directed to cause a certified copy of this resolution to be recorded in the office of the County Recorder of Riverside County, California.
