RESOLUTION NO. 75-115
ABANDONMENT OF A PORTION OF VAN BUREN BOULEVARD
(R-688 - Woodcrest Area)

WHEREAS, pursuant to Section 959 of the Streets and Highways Code, a public hearing after due notice has been held upon a resolution of intention to abandon the northerly 10-foot portion of Van Buren Boulevard in the Woodcrest area, Fifth Supervisorial District, and all persons having had an opportunity to be heard; now, therefore,

BE IT RESOLVED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on April 22, 1975, that the following portion of Van Buren Boulevard located between Dauchy Road and Wood Road in the Woodcrest area, Fifth Supervisorial District, is hereby vacated and abandoned:

The northerly 10 feet of the unnamed street (now known as Van Buren Boulevard - 30 feet wide) lying southerly of and adjacent to Blocks 8, 9, 24, 25, 40, 41, 56, 57 and 72 of Oak Glen Tract, as shown by map on file in Book 5, page 130, of Maps, Records of Riverside County, California.

Excepting therefrom the westerly 44 feet. Also excepting those areas contained within the southerly prolongation of the easterly and westerly lines of Shorb Street, Pico Street, Akron Street, El Molino Street, Grant Street, and Ramona Street as shown on said map.

Reserving easements for existing public utilities or public service facilities.
