3 RESOLUTION NO. 83-58

4 ACCEPTING OFFERS OF DEDICATION FOR PUBLIC ROADS

5 (Third and Fifth Supervisorial Districts)

7 WHEREAS the hereinafter-listed roads were offered for dedication
8 for public road purposes on the Parcel Maps, Tract Maps, Certificates of
9 Dedication, and Declarations of Dedication hereinafter referred to, which
10 offers of dedication have not previously been accepted by the County, now
11 therefore,

12 BE IT RESOLVED, FOUND, AND DETERMINED by the Board of Supervisors
13 of the County of Riverside, State of California, in regular session assembled
14 on March 15, 1983, that this Board accepts the offers of dedi-
15 cation and recognizes that said roads are public roads open for use by the
16 general public.

17 BE IT FURTHER RESOLVED, FOUND, AND DETERMINED that this acceptance
18 is for the purpose of vesting title in the County of Riverside on behalf of
19 the public for public road and utility uses and is not an acceptance of the
20 roads into the County maintained road system pursuant to Section 941 of the
21 Streets and Highways Code; that said roads shall not become a part of the
22 County maintained road system unless subsequently accepted into the maintained
23 road system by resolution adopted by this Board.

24 Said roads are in the County of Riverside, State of California, and
25 are described as follows:

26 That portion of Lot F, designated as Bradley Road, lying
27 northerly of the westerly prolongation of the southerly line of
28 Lot E in Block 15, as said lots and block are shown on Map of
Fair View Farms, Walnut Addition No. 1, filed in Map Book 16,
Page 50, Riverside County records.

records.

10 That portion of Lot C, designated as Nance St., as shown on
11 map of Golden Valley Farms Unit No. 2, filed in Map Book 15,
12 Page 10 and 11, Riverside County records, lying easterly of the
easterly line of Wade Ave. as now located.

13 Lot B, designated as Indian St., as said lot is shown on
14 Parcel Map No. 6766, filed in Parcel Map Book 32, Page 35, Riverside
County records.

15 An unnamed road dedicated for public road purposes by Declara-
16 tion of Dedication, recorded January 27, 1975, as Instrument No.
10395, Riverside County records.

17 That portion of an unnamed street, now known as Indian Street,
18 lying in Block 1 as shown on map of Riverside Alfalfa Acres, filed
19 in Map Book 8, Page 21, Riverside County records, lying southerly
of Mandina Ave. and northerly of the Perris Valley Storm Drain as
said avenue and drain are now located.

21 Del Vino, and De Portola Road, together with corner cutbacks and
