hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation, the real property
in the City of Riverside, County of Riverside, State of California, described as
follows:

All that portion of Lot N (Holden Avenue), as shown by Tract No. 2 of La
Sierra Heights, on file in Book 7, Page 66 of Maps, records of said
Riverside County, more particularly described as follows:

COMMENCING at the most southerly corner of Lot 4 in Block 67 as shown by
said Tract No. 2 of La Sierra Heights;

THENCE Southwesterly along the southwesterly prolongation of the north-
westerly line of said Lot 4 as distance of 40.15 feet, more or less, to its
intersection with the southwesterly line of the northeasterly 40.00 feet of


