E A S E M E N T

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,  
RICHARD T. BROWN, a married man,

as Grantor, grants to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, as Grantee, its successors and assigns, a perpetual easement and right of way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of storm drain facilities

together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

A strip of land 6.00 feet wide within Lot 13 of Tract No. 9793-2, as shown on map on file in Book 137 of Maps, Pages 73 through 75 inclusive, in the office of the County Recorder for said Riverside County, said 6.00 foot strip being described as follows:

BEGINNING at the southeast corner of said Lot 13;

THENCE North 40° 28' 55" East along the easterly line of said Lot a distance of 113.86 feet to the northeast corner of said Lot;

THENCE North 59° 01' 42" West along the northerly line of said Lot a distance of 6.08 feet to a point in a line parallel with and 6.00 feet westerly, measured at right angles from said easterly line;

THENCE South 40° 28' 55" West along said parallel line 112.85 feet to a point in the southerly line of said Lot, said southerly line being a curve concave to the north and having a radius of 1860.08 feet;

THENCE Easterly along said southerly line through a central angle of 0° 11' 05" an arc distance of 6.00 feet to said point of beginning.

EXCEPTING therefrom that portion of said easement lying within that certain 12.00 foot wide storm drain easement as dedicated to the City of Riverside by said Tract No. 9793-2.



CONSENT TO RECORDATION


