**TREE PLANTING EASEMENT**

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,  
COUNTRYWOOD DEVELOPMENT, a general partnership,

as Grantor, grant to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, as Grantee, a perpetual easement and right of way for the tree planting, renewing and maintaining of trees of such types as shall be designated by the City of Riverside in, under, upon, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

A strip of land 4.00 feet in width over a portion of Lot 3 in Block 43 of the Riverside Land and Irrigating Company, as shown by map on file in Book 1 of Maps, at Page 70 thereof, records of San Bernardino County, California; the northwesterly line of said 4.00 foot strip being more particularly described as follows:

BEGINNING at the most northerly corner of Lot 1 of Tract 9787, as shown by map on file in Book 143 of Maps, at Pages 5 and 6 thereof, records of Riverside County;

THENCE North 47° 24' 38" East, a distance of 7.70 feet to the beginning of a tangent curve, concave northwesterly and having a radius of 124.00 feet;

THENCE Northeasterly along said curve an arc length of 44.26 feet, through a central angle of 20° 26' 59" to a point of reverse curve with a curve concave southeasterly and having a radius of 76.00 feet;

THENCE Northeasterly along said curve having a radius of 76.00 feet, an arc length of 39.01 feet, through a central angle of 29° 24' 35" to a line that is parallel with and distant 114.00 feet southeasterly, as measured at right angles to the centerline of Magnolia Avenue;

THENCE North 56° 22' 14" East, along said parallel line, a distance of 243.88 feet to a point on the easterly line of said Lot 3 and the end of this line description.



