GRANT DEED

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, do hereby
grant to the CITY OF RIVERSIDE, a municipal corporation, the real property in
the City of Riverside, County of Riverside, State of California, described as
follows:

That portion of the Northwest Quarter of the Fractional Southwest
Quarter of Section 11, Township 3 South, Range 5 West, San Bernardino
Meridian, as shown by the United States Government survey, described as
follows:

COMMENCING at the Southeast corner of the said Northwest Quarter of
Fractional Southwest Quarter of Section 11;

THENCE N 0° 02' 27" W, along the easterly line of said Northwest
Quarter of Fractional Southwest Quarter of Section 11, a distance of
20.00 feet, to a point on a line parallel to and 20.00 feet northerly,
as measured at right angles from the southerly line of said Northwest
Quarter of Fractional Southwest Quarter of Section 11;

THENCE S 89° 40' 10" W, along said parallel line, a distance of 695.40
feet, to the beginning of a tangent curve, concave northwesterly and
having a radius of 1000.00 feet;
