A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING A PORTION OF AN OFFER OF DEDICATION OF CERTAIN PROPERTY FOR STREET PURPOSES TO BE KNOWN AS A PORTION OF EASTRIDGE AVENUE. **11589**

WHEREAS in connection with the approval of Parcel Map 162 certain property was irrevocably offered for dedication for public street and highway purposes together with all rights to construct and maintain utilities, sewers, drains, and other improvements consistent with the use as a public street and highway, by Josephine G. Barker, Miguel J. Garat and Edith Garat in the Offer of Dedication dated December 18, 1974 and recorded January 10, 1975 in Book 1975, Page 3442, Official Records of Riverside County, California; and

WHEREAS in connection with the proposed Canyon Springs sewer line lateral and the sewer connections to serve the Canyon Springs Assessment District (sewer extension for Parcel Map 91617), a portion of said property offered for dedication needs to be incorporated into EASTRIDGE AVENUE;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

1. That the hereinafter described portion of the property irrevocably offered for dedication to the City of Riverside in that Offer of Dedication recorded January 10, 1975, in Book 1975, Page 3442, Official Records of Riverside County, California, is hereby accepted by the City of Riverside for street purposes to become and be known as a portion of Eastridge Avenue, together with all rights to construct and

Beginning at the northeast corner of said Parcel 1; Thence South 89° 26' 30" West, along the north line of said Parcel a distance of 70.00 feet; Thence South 0° 33' 30" East, 30.00 feet; Thence North 89° 26' 30" East, 69.89 feet to the east line of said Parcel; Thence North 0° 21' 15" West, along said east line 30.00 feet to the Point of Beginning.

2. That the City Clerk is authorized and directed to cause a certified copy of this resolution to be recorded in the Office of the County Recorder of Riverside County, California.
