OFFER OF DEDICATION

On this 15th day of August, 1986, the ROMAN CATHOLIC BISHOP OF SAN BERNARDINO, a corporation sole, as to an undivided 25% interest; and the ROMAN CATHOLIC BISHOP OF SAN DIEGO, a corporation sole, as to an undivided 50% interest; and PRESIDENT AND FELLOWS OF HARVARD COLLEGE, a Massachusetts corporation, as to an undivided 25% interest; irrevocably offer for dedication to the CITY OF RIVERSIDE, a municipal corporation, pursuant to the provisions of California Government Code Section 7050, for public street and highway purposes, together with all rights to construct and maintain utilities, sewers, drains and other improvements consistent with the use as a public street and highway, that real property located in the City of Riverside, County of Riverside, State of California, described as follows:
