GRANT OF EASEMENT

RIVERSIDE UNIFIED SCHOOL DISTRICT, Grantor FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, does hereby grant to the CITY OF RIVERSIDE, a municipal corporation, an easement and right-of-way for public street and highway purposes, together with all rights to construct and maintain utilities, sewers, drains and other improvements consistent with the use as a public street and highway, in, under, upon, over and along that certain real property in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of the southerly 8.00 feet of the northerly one-half of Violet Street (vacated) of Olive Heights, as shown by map on file in Book 5, Page 163 of Maps, records of said Riverside County, lying westerly of the southerly prolongation of the westerly line of Columbine Avenue, as shown by said map of Olive Heights, and lying easterly of the westerly line of Iowa Avenue Extension (vacated), as shown by said map of Olive Heights;

TOGETHER WITH that portion of said Violet Street (vacated), described as follows:

COMMENCING at a point on the northerly line of said southerly 8.00 feet with the westerly line of said Iowa Avenue Extension (vacated);

THENCE easterly along said northerly line, a distance of 8.00 to the easterly line of that certain parcel of land conveyed to the City of Riverside by Grant Deed recorded January 25, 1980, as Instrument No. 17223 of Official Records of said Riverside County;


