WHEREAS on October 28, 1986, the City Council of the City of Riverside adopted Resolution No. 16292 declaring its intention to order the vacation of a portion of Correll Street, South of Jurupa Avenue between Jurupa Avenue and Dewey Street, and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Public Streets, Highways, and Service Easements Vacation Law, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Public Streets, Highways, and Service Easements Vacation Law; and

WHEREAS on the day fixed for the hearing the City Council heard and found and hereby finds from all of the evidence submitted that the portion of Correll Street ordered vacated is unnecessary for present or prospective public use;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, that the portion of Correll


1 Street in the City of Riverside, County of Riverside, State of
2 California, described in the document attached hereto, marked
3 Exhibit A, and by this reference made a part hereof, be and the
4 same is hereby vacated.

5 BE IT FURTHER RESOLVED that the City Council does hereby
6 determine that the public convenience and necessity require the
7 reservation of permanent easements and rights of way for storm
8 drain and waterline facilities, and reserving the right to
9 construct, maintain, operate, replace, remove, renew and enlarge
10 lines of pipe, conduits, cables, wires, poles and other
11 convenient structures, equipment and fixtures, as may be
12 applicable, for the operation of storm drains and for the
13 transportation or distribution of water; including access and
14 the right to keep the property free from inflammable materials
15 and wood growth that would interfere with the use of said
16 permanent easements and rights of way.


17 BE IT FURTHER RESOLVED that the vacation shall occur
18 only after the applicable conditions contained in the Planning
19 Department's report to the legislative body dated May 13, 1986,
20 and on file with the City Clerk have been satisfied; and the
21 City Clerk is hereby directed not to record this resolution of
22 vacation until the applicable conditions have been satisfied.


