Lot "G" of Tract 21403-2 as shown by map on file in Book 170 of Maps at pages 18 through 22 thereof, Records of Riverside County, California.


Lot "I" of Tract 20403-1 as shown by map on file in Book 170 of Maps at pages 14 through 17 thereof, Records of Riverside County, California.




