TEMPORARY CONSTRUCTION
EASEMENT

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, BRADLEY R. KARMANN and DEBRA L. KARMANN, husband and wife as joint tenants, as Grantors, grant to the CITY OF RIVERSIDE, a municipal corporation, as Grantee, its successors and assigns, a temporary easement and right-of-way for the construction and installation of public street and sidewalk facilities together with all necessary appurtenances, in, under, upon, over and along that certain real property in the City of Riverside, County of Riverside, State of California, described as follows:

The northeasterly 10.00 feet of the southwesterly 15.00 feet of Lot 12 of Tract No. 2405, as shown by map on file in Book 44 of Maps, at Pages 49 thru 51 inclusive thereof, records of Riverside County, California, said southwesterly 15.00 feet being northeasterly of and contiguous with the northeasterly line of Alessandro Boulevard.

AREA - 906.47 square feet.

Said temporary construction easement is to be used for all purposes proper and convenient in the construction and installation of public street and sidewalk facilities, including the rights of ingress and egress, the temporary deposit of tools, equipment, machinery, vehicles, materials and supplies used

in the performance of said work, and for similar and related purposes by the City of Riverside, its officers, employees, agents or contractors.

Upon completion of construction, the City of Riverside shall remove all debris, waste or excess material, brush or other matter or material deposited or placed upon the land, and with the exception of vegetation, return the surface as near as possible to its condition before construction.

This construction easement shall terminate upon completion of the work of constructing the public street and sidewalk or within one year of the date of recording this document, whichever occurs first.






