OFFER OF DEDICATION

On this 11th day of July, 1988, NEIL C. HANSEN, JR. and SANDRA K. HANSEN, husband and wife, irrevocably offer for dedication to the CITY OF RIVERSIDE, a municipal corporation, pursuant to the provisions of California Government Code Section 7050, for pedestrian and equestrian trail purposes, together with all rights to construct and maintain pedestrian and equestrian trail improvements consistent with the use as a pedestrian and equestrian trail, that real property located in the City of Riverside, County of Riverside, State of California, described as follows:


