E A S E M E N T

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, CROW-LANE-RIVERSIDE #2 LIMITED PARTNERSHIP, a Texas limited partnership, as Grantor, grants to the CITY OF RIVERSIDE, a municipal corporation, as Grantee, its successors and assigns, an easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of the storm drain facilities, together with all necessary appurtenances, in, under, upon, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 24 in Section 19, Township 2 South, Range 4 West, of Lands of the East Riverside Land Co., on file in Book 6, Page 44 of Maps, records of San Bernardino County, California, described as follows:

COMMENCING at the intersection of the northerly line of Lot 25 of said Lands of the East Riverside Land Co., with the east line of the west half of said Lot 25;

THENCE South 00° 10' 46" West, along said east line a distance of 10.00 feet to the true POINT OF BEGINNING;

THENCE North 89° 50' 50" West, parallel with the northerly line of said Lot 25 a distance of 204.74 feet to the beginning of a tangent curve, concaving northeasterly and having a radius of 80.00 feet;

THENCE northwesterly along said curve an arc length of 125.73 feet, thru a central angle of 90° 03' 00" to end thereof;

THENCE radially North 89° 47' 50" West, 2.50 feet to a line which is parallel with and distant 61.50 feet easterly as measured at right angle from the centerline of Chicago Avenue;

THENCE South 00° 12' 10" West, along said parallel line 56.51 feet to the beginning of a non-tangent curve, concave northeasterly, having a radius of 100.00 feet and being concentric with hereinabove described curve with a radius of 80.00 feet; the radial line of said non-tangent curve at said beginning bears South 55° 47' 29" West;

THENCE southeasterly along said non-tangent curve an arc length of 97.11 feet thru a central angle of 55° 38' 19";

THENCE South 89° 50' 50" East, parallel with said northerly line of Lot 25 a distance of 204.74 feet to said east line of the west half of Lot 25;

THENCE North 00° 10' 46" East, along said east line 20.00 feet to said true POINT OF BEGINNING;

EXCEPTING THEREFROM any portion within said Lot 25.

TOGETHER WITH the right to clear and keep clear said easement and right-of-way from any structures or trees, to enter upon and to pass and repass over and along said property, and to deposit tools, implements and other material thereon by Grantee, its officers, agents and employees and by persons under contract with said Grantee and their officers, agents and employees, whenever and wherever necessary for the purpose of constructing, reconstructing, maintaining, operating, inspecting, repairing, replacing, relocating, renewing and removing said storm drain facilities.





