WHEREAS the City of Riverside, in connection with concluding the sale of the Lincoln/Mary Street Library site, requires the dedication and acceptance of a portion of certain City-owned land currently a portion of Parcel 2 of that Record of Survey hereinafter described;

is hereby dedicated by the City of Riverside for public use for street purposes to become and be known as a portion of Lincoln Avenue.
