A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING A ONE-FOOT BARRIER STRIP WITHIN TRACT NO. 8184-1 (WHICH BARRIER STRIP ADJOINS TRACT NO. 19997) FOR STREET PURPOSES TO BE KNOWN AS A PORTION OF FUCHSIA PLACE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strip is hereby accepted to public use for street purposes to be known as a portion of Fuchsia Place: **12605**

That portion of Lot "E" (one-foot Barrier Strip) of Tract No. 8184-1, as shown by map on file in Book 116, Pages 19 and 20 of Maps, records of Riverside County, California, the southwesterly and northwesterly lines being described as follows:

Beginning at the most southerly corner of Lot 16 of said Tract No. 8184-1;
Thence South 34° 00' 59" East, 212.05 feet;
Thence South 56° 02' 45" West, 12.68 feet to the end of this line description. The preceding two courses being along the boundary of said Tract No. 8184-1.




