E A S E M E N T

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, REGIONAL PROPERTIES, INC., a California corporation, as Grantor, grants to the CITY OF RIVERSIDE, a municipal corporation, as Grantee, its successors and assigns, an easement and right-of-way for the construction, reconstruction, maintenance, operation, inspection, repair, replacement, relocation, renewal and removal of electric energy distribution facilities, together with all necessary appurtenances, in, under, upon, over and along that certain real property located in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Parcel 11 of Parcel Map No. 4806, as shown by map on file in Book 7, Pages 8 through 12 of Parcel Maps, records of Riverside County, California, described as follows:

BEGINNING at the most easterly corner of Lot "E" of Parcel Map 23178, as shown by map on file in Book 158, Pages 20 through 22 of Parcel Maps, records of said Riverside County;

THENCE North 62° 44' 18" West, along the northeasterly line of said Lot "E" and along the northeasterly line of Lot "D" of said Parcel Map 23178, a distance of 15.00 feet;

THENCE North 27° 15' 42" East, a distance of 4.00 feet;

THENCE South 62° 44' 18" East, parallel with said northeasterly line, a distance of 15.00 feet;

THENCE South 27° 15' 42" West, a distance of 4.00 feet to the POINT OF BEGINNING.

TOGETHER WITH the right to clear and keep clear said easement and right-of way from any structures or trees, to enter upon and to pass and repass over and along said real property, and to deposit tools, implements and other material thereon by Grantee, its officers, agents and employees and by persons under contract with said Grantee and their officers, agents and employees whenever and wherever necessary for the purpose of constructing, reconstructing, maintaining, operating, inspecting, repairing, replacing, relocating, renewing and removing said electric energy distribution facilities.


