A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING THE OFFER OF DEDICATION FOR DRAINAGE PURPOSES THOSE AREAS DESIGNATED AS 30 FOOT DRAINAGE EASEMENT AND SPECIAL DRAINAGE EASEMENT ON THE FINAL MAP FOR TRACT NO. 4510.

WHEREAS on July 31, 1974, the final map for Tract No. 4510 was recorded in Book 81 of Maps, at Pages 3 and 4 thereof, records of Riverside County, California; and

WHEREAS Tract No. 4510 is located in the vicinity of Box Springs Boulevard and Eastridge Avenue and was then in the unincorporated area of the County of Riverside; and

WHEREAS Box Springs Company, a partnership, as the owner of the property included in Tract No. 4510 at time of recordation of the final map offered for dedication for drainage purposes those areas designated on said map as 30 foot Drainage Easement and Special Drainage Easement; and

WHEREAS when the Board of Supervisors of the County of Riverside approved the final map of Tract No. 4510, the dedications made thereon were not accepted; and

WHEREAS the area has since been annexed to the City of Riverside; and

WHEREAS a project is planned to put a concrete channel and appurtenances in the easements of Tract No. 4510 not hereinabove accepted for drainage in conjunction with construction of Freeway 215 upstream of Tract No. 4510; and

WHEREAS in order to accommodate this construction, it is necessary that the City of Riverside now accept the offer of

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

1. That the 30 foot Drainage Easement and the Special Drainage Easement as shown on the final map for Tract No. 4510 recorded July 31, 1974 in Book 81 of Maps, at Pages 3 and 4 thereof, records of Riverside County, California, and as offered for dedication thereon are hereby accepted by the City of Riverside for drainage purposes together with the right to construct and maintain thereon storm drain facilities and appurtenances relating thereto.

2. That the City Clerk of the City of Riverside is hereby authorized and directed to cause a certified copy of this resolution to be recorded in the office of the County Recorder for Riverside County, California.


