A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING OFFERS OF DEDICATION FOR STORM DRAIN FACILITIES RELATING TO STAGE 4 OF THE ARLINGTON CHANNEL STORM DRAIN.

WHEREAS between November 1977 and May 1985 several subdivisions in the area between Harrison and Tyler Streets southeasterly of the Atchinson, Topeka and Santa Fe Railway Company tracks were approved by the City of Riverside; and

WHEREAS as a condition of approval of the various tract maps, the owners thereof were required to irrevocably offer for dedication on their respective maps, easements for storm drain facilities which could be incorporated into the Arlington Channel Storm Drain System of the Riverside County Flood Control and Water Conservation District; and

WHEREAS the City of Riverside did not accept these offers of dedication at the time the respective tract maps were recorded as there was no scheduled construction for the storm drain facilities, but the City of Riverside reserved all rights to accept such dedications at anytime thereafter; and

WHEREAS the Riverside County Flood Control and Water Conservation District will soon be soliciting bids for the construction of this portion of the Arlington Channel Storm Drain and has requested the City of Riverside to transfer the necessary storm drain easements to the District to accommodate such construction; and

WHEREAS the City of Riverside is willing to now accept the appropriate offers of dedication for storm drain facilities

1 and subsequently transfer such easements to the Riverside
2 County Flood Control and Water Conservation District to be
3 included in Stage 4 of the Arlington Channel Storm Drain;

4 NOW, THEREFORE, BE IT RESOLVED by the City Council of
5 the City of Riverside, California, as follows:

6 Section 1: That Lot "L" of Tract No. 9297, as shown by
7 map on file in Book 94, Pages 5 through 11 of Maps, records of
8 Riverside County, California, offered for dedication on the
9 final map of Tract 9297 by PACESETTER HOMES, INC., a California
10 corporation, **is hereby accepted** for the construction and
11 maintenance of storm drain facilities.

12 Section 2: That Lot "E" of Tract 9200-1, as shown by
13 map on file in Book 119, Pages 4 through 6 of Maps, records of
14 Riverside County, California, offered for dedication on the
15 final map of Tract 9200-1 by STANDARD-PACIFIC CORP. **is hereby**
16 **accepted** for the construction and maintenance of storm drain
17 facilities.

18 Section 3: That Lot "D" of Tract 9200-2, as shown by
19 map on file in Book 119, Pages 7 and 8 of Maps, records of
20 Riverside County, California, offered for dedication on the
21 final map of Tract 9200-2 by STANDARD-PACIFIC CORP. **is hereby**
22 **accepted** for the construction and maintenance of storm drain
23 facilities.

24 Section 4: That Lot "E" of Tract 9200, as shown by map
25 on file in Book 127, Pages 1 and 2 of Maps, records of
26 Riverside County, California, offered for dedication on the
27 final map of Tract 9200 by STANDARD-PACIFIC CORP. **is hereby**

1 **accepted** for the construction and maintenance of storm drain
2 facilities.


3 Section 5: That Lot "E" of Tract 20231, as shown by
4 map on file in Book 150, Pages 60 through 64 of Maps, records
5 of Riverside County, California, offered for dedication on the
6 final map of Tract 20231 by SHELBURNE DEVELOPMENT CORPORATION
7 **is hereby accepted** for the construction and maintenance of
8 storm drain facilities.

9 Section 6: That the City Clerk of the City of
10 Riverside is authorized and directed to cause a certified copy
11 of this resolution to be recorded in the Office of the County
12 Recorder of Riverside County, California.



