GRANT DEED

MAX L. CARDEY and HELEN N. CARDEY, Trustees of the Cardey Family 1988 Living Trust,
as Grantors, FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,
do hereby grant to the CITY OF RIVERSIDE, a municipal corporation of the State of
California, as Grantee, its successors and assigns, the real property located in the City of
Riverside, County of Riverside, State of California, described as follows:

Those portions of Lots 7 and 8 in Block 14 of White's Addition as shown by
map on file in Book 6 of Maps, at page 48 thereof, records of San Bernardino,
California, described as follows:

COMMENCING at the most northerly corner of said Lot 7;

THENCE South 61°05'37" East, along the northeasterly line of said Lot 7, a
distance of 4.93 feet to the **TRUE POINT OF BEGINNING;**

THENCE South 61°05'37" East, along the northeasterly lines of Lots 7 and 8
a distance of 86.04 feet to a cusp of a non-tangent curve concave southerly

and having a radius of 108.00 feet; the radial line to said cusp bears North 02°49'19" East;

THENCE westerly, along said curve, an arc length of 24.74 feet through a central angle of 13°07'32" to the beginning of a reverse curve concave northerly and having a radius of 43.00 feet; the radial line to the beginning of said reverse curve bears South 10°18'13" East;

THENCE westerly, northwesterly and northerly, along said curve, an arc length of 76.17 feet through a central angle of 101°29'32" to a point in said northeasterly line of Lot 7 and said **TRUE POINT OF BEGINNING**.




