2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY
3 OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF
4 THAT PORTION OF ADAMS STREET LOCATED BETWEEN
5 CENTRAL AVENUE AND MOUNTAIN VIEW AVENUE TO
6 ESSEX STREET.

7 WHEREAS when the City Council of the City of Riverside
8 approved the updated General Plan for the City of Riverside in
9 1994, the extension of Adams Street between Arlington Avenue and
10 Central Avenue across the Riverside Municipal Airport was deleted
11 from the Streets and Highways Diagram of the Transportation
12 Element; and

13 WHEREAS the deletion of Adams Street across the Riverside
14 Municipal Airport leaves an approximately 0.5 mile section of
15 Adams Street northerly of the Riverside Municipal Airport between
16 Central Avenue and Mountain View Avenue which essentially
17 continues as Essex Street northerly of Mountain View Avenue; and

18 WHEREAS the section of Adams Street northerly of the
19 Riverside Municipal Airport is shown on the General Plan as a 66-
20 foot wide local collector street, while the section of Adams
21 Street southerly of Arlington Avenue is a planned four lane, 110-
22 foot-wide arterial; and

23 WHEREAS the properties adjacent to that section of Adams
24 Street northerly of the Riverside Municipal Airport located
25 between Central Avenue and Mountain View Avenue are single family
26 residences or vacant land with the adjacent residences on reverse
27 frontage lots with no direct access onto Adams Street; and

WHEREAS in Street Name Change No. NC-001-956, on
December 21, 1995, the Planning Commission of the City of

1 Riverside considered the request of the Public Works Department
 2 of the City of Riverside to change the name of that portion of
 3 Adams Street between Central Avenue and Mountain View Avenue to
 4 Essex Street and approved such request and forwarded its
 5 recommendation to the City Council of the City of Riverside; and

6 WHEREAS on January 9, 1996, the City Council approved the
 7 name change; and

8 WHEREAS it would now be appropriate to finalize the
 9 street name change as authorized by the City Council of the City
 10 of Riverside;

11 NOW, THEREFORE, BE IT RESOLVED by the City Council of the
 12 City of Riverside, California, that the name of that portion of
 13 ADAMS STREET between CENTRAL AVENUE and MOUNTAIN VIEW AVENUE
 14 described as follows:

15 That portion of ADAMS STREET bounded southerly by Central
 16 Avenue and bounded northerly by Mountain View Avenue.

17 be changed to **ESSEX STREET**.

18 BE IT FURTHER RESOLVED that the City Clerk of the City of
 19 Riverside is authorized and directed to cause a certified copy of
 20 this resolution to be recorded in the office of the County
 21 Recorder of Riverside County, California.

22 ADOPTED by the City Council and signed by the Mayor and
 23 attested by the City Clerk this 6th day of February, 1996.
