A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE STREET NAME OF THAT PORTION OF PIERCE STREET FROM MAGNOLIA AVENUE TO THE SOUTHERLY ENTRANCE OF THE MOBILE HOME PARK AT 4000 PIERCE STREET AND FOR THE APPROXIMATELY 870-FOOT-LONG SECTION OF GOLDEN AVENUE EXTENDING SOUTHERLY FROM PIERCE STREET, BOTH SEGMENTS TO BE NAMED "*RIVERWALK PARKWAY*".

WHEREAS, Griffin Industries has requested a street name change for portions of Pierce Street and a section of Golden Avenue extending from Pierce to "*RiverWalk Parkway*"; and

WHEREAS, the proposed street name change would also establish "*RiverWalk Parkway*" as the street name for a new 110-foot arterial street that will bisect the La Sierra University Specific Plan area; and

WHEREAS, the Planning Commission approved formally recognizing the proposed street name change on January 7, 2000; and


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, that the street name change of that portion of Pierce Street from Magnolia Avenue to the southerly entrance of the mobile home park located at 4000 Pierce Street and for the approximately 870-foot-long section of Golden Avenue extending southerly from Pierce Street in the City Limits of the City of Riverside, as more specifically set forth in the attached Exhibit "A", and incorporated herein by reference, be changed to **RIVERWALK PARKWAY**.

BE IT FURTHER RESOLVED that the City Clerk of the City of Riverside is authorized and directed to cause a certified copy of this resolution to be recorded in the office of the County Recorder of Riverside County, California.




